TERMS AND CONDITIONS

Becky Ryan Photography - Terms & Conditions

In the following conditions of contract "the photographer" shall mean Becky Ryan or any photographer(s) appointed by Becky Ryan Photography.

"The Clients" shall be those whose names appear on the email invoice. These terms & conditions cannot be varied in any way by the client(s) unless such conditions are expressly agreed by the photographer in writing

1.

Copyright:

The Copyright and Design Act 1988 assigns the copyright of the images to the photographer.

The Client(s) will have the right to reproduce the images therein for personal use only and not for distribution of any kind.

2.

Display:

The Clients hereby allow the photographer to display any images covered by this contract and to generally promote the business by means of advertising, publicity material, websites, exhibitions, competitions, magazine articles, and other such media, providing that the images are used lawfully and without damage to the clients.

3. Licence and Coverage:

a) The photographer shall be granted artistic licence in relation to the poses photographed and the locations used. Although every effort will be made to comply with the Clients' requirements, the photographers' judgment regarding the location, poses and number of photographs taken shall be deemed correct.

b) For bookings involving a church ceremony or at certain other venues, photographers' movements are sometimes restricted by the minister or official in charge: photographing of parts or even all of the ceremony may be restricted or prohibited, as may the use of artificial lighting. The photographers cannot accept responsibility for limited coverage in such cases.

c) Whilst the photographer shall endeavour to fulfil all the Clients' requirements, they cannot be held responsible for non-availability of subjects or adverse conditions which may delay the progress of proceedings, preventing the coverage of certain specified shots.

d) Any alterations made to the booking by the Clients once details have been confirmed may only be made at the discretion of the photographers. If unable to accommodate alternative arrangements (such as the change of ceremony date or venue) the photographers are not liable to compensate the client(s) in any way whatsoever.

4. Image Reproduction:

a) Owing to photo-chromatic anomalies caused by a combination of certain dyes and materials, especially in man-made fibres, it is sometimes impossible to record on camera the exact colour of materials as perceived by the human eye. When processing images, the photographers will endeavour to achieve a pleasing overall colour balance based on natural flesh tones.

b) It is understood that some colours may not remain consistent throughout a set of photographs owing to variations in lighting conditions. It is also understood that all photographic printing is undertaken within the technical limitations of the process and that colour may not be identical over the whole range within a subject. The colour balance of prints made at different times or in varying sizes may also be variable.

c) Due to the limitations of computer monitors it is understood that images may appear differently according to the specification of each monitor and that prints will not match images rendered on any particular computer monitor.

d) The Photographer will ensure each USB of images is checked before dispatch, but it remains the responsibility of the clients to check discs for in-transit damage. The photographer cannot be held responsible for damage to equipment resulting from defective media.

5. Payment and Prices:

a) A non-refundable booking fee of 50% of the package price is required to secure the photographers' services for the day, with the relevant balance for each package due 4 weeks prior to the event.

b) Albums can be purchased separately up until 1 month after the wedding date, with additional copies available to purchase up to 1 year after.

c) Return journeys in excess of 50 miles may attract a mileage charge or train fare. Overnight accommodation may be required for weddings over 100 miles away.

6. Cancellation:

a) In the highly unlikely event of cancellation by both photographers, or unavoidable total photographic failure, the photographers' liability shall be limited to a full refund of any booking fees and fees paid. Re-shoots may be arranged if possible but the photographers will not be responsible for any further costs.

b) The photographer will endeavour to appoint other photographers in the unlikely event that she is unable to attend a booking. However it may prove difficult or impossible to find a skilled replacement photographer at short notice or at the same price.

c) If the Clients should have to cancel a booking the following cancellation fees will become due immediately:

1. The Clients are entitled to a full refund of their deposit if they withdraw within 7 days of booking.

2. The deposit will be forfeited on cancellations made after 7 days. Cancellations made within one month of the wedding incur the full cost of the basic photographic service booked, including optional additional attendance.

3. Where the photographer is able to rebook the date with an equivalent booking, the cancellation fee will be reduced to the non-refundable booking fee only and any additional cancellation fees already paid will be refunded accordingly.

4. In the event of postponement, then at the discretion of Becky Ryan Photography, and subject to availability, monies other than the booking fee may be applied to the new wedding.

5. It is essential to inform the photographer as soon as possible of any changes of venue, times, or contact details etc.

7. Extras

a)

The client shall provide a pescatarian meal for the photographers in attendance for any bookings longer than 5 hours. Soft drinks must be made available for all bookings. If this is not viable, the photographer must be informed in due time before the event.

b)

Any additional media ordered such as albums following the included USB are to be collected by the clients from Belper, Derbyshire, unless otherwise agreed in writing. The photographer can post things out for an additional fee but can not be held responsible for any damage during transit once it has gone into the hands of a delivery service.
